The after-tax profit in the company's Q2/2025 financial statements reached VND 6.11 billion (a decrease of VND 1.38 billion), equivalent to a 29.19% decrease compared to Q2/2024.

Reason:

In the first half of 2025, the Company actively expanded its commercial operations — increasing the sales volume of plastic resins — and ventured into a new business line: LPG trading. These efforts contributed to a revenue surge of VND 198.67 billion, marking a growth of over 120.70% compared to the same period last year.

In addition, the Company enhanced its financial investment activities, leading to an increase in financial income of more than VND 870 million, equivalent to a year-over-year growth of over 97.01%.

As a result, gross profit rose by approximately VND 5.3 billion, representing an increase of 65.37% versus the prior-year period. Net profit after corporate income tax, as recorded in the Q2-2025 financial statements, increased by VND 1.38 billion — up 29.19% compared to Q2-2024.
